## Brief Summary of Bills

## Long Term Homeless

 LR 562 – FUSE – Requires collaboration between providers, state departments and Maine Housing on resources for those experiencing long term homelessness.

## Emergency Shelter

- LR 1094 Emergency Shelter Funding Bill Carry over from last session providing for \$3,000,000 in shelter funding.
- LR 1096 Emergency Shelter Bond would provide funding for construction of or capital improvements to Maine's Emergency Shelters
- LR 1419 Improving Housing Access Under General Assistance (GA) Streamlines the process for shelters to bill GA for shelter benights.

# Brief Summary of Bills (continued)

#### Homeless Prevention

- LR 873 Eviction Mediation Program Establishes a court eviction mediation program and makes permanent the court eviction process currently in place under Covid-19
- LR 1904 Unnecessary Evictions Restricts the use of 30-day no cause evictions for tenants-at-will.
- LR 18420 Eviction Record Privacy Protects renters from the improper use of court filings against them in applications to housing.

#### Rental Assistance

- LR 1882 Prohibits discrimination against individuals based on their source of rent income for rent including housing choice voucher assistance.
- LR 1419 Improving Housing Access Under General Assistance (GA) In addition to shelter language (previous slide), the bill makes rental assistance under GA more akin to a short-term youcher.

# Brief Summary of Bills (continued)

## Housing Production

- LR 1312; LR 1448 Efficient Affordable Housing Bonds– Raises funds for the increased creation of efficient, affordable housing.
- LR 272 Housing for Person who are Homeless waiting for bill language for more detail.

## Zoning

 LR 354 – Zoning Commission – Carryover from last session, would create a zoning commission to look at local zoning barriers to affordable housing production.
